

PROCEEDINGS TO SET DATE FOR  
HEARING AND LETTING

Griswold, Iowa

July 13, 2020

The City Council of the City of Griswold, Iowa, met at the Community Building Small Room, Griswold, Iowa, on July 13, 2020, at 6:00 o'clock p.m. The Mayor presided and the roll being called, the following named Council Members were present and absent:

Present: Adams, Preston, Sorensen, Stapleton

Absent: Askeland

The Council took up and considered the proposed FEMA Creek Bank Repairs Project. Council Member Sorensen introduced the resolution next hereinafter set out and moved its adoption, seconded by Council Member Adams. After due consideration thereof by the Council, the Mayor put the question upon the adoption of the said resolution and the roll being called, the following named Council Members voted:

Ayes: Adams, Preston, Sorensen, Stapleton

Nays: none.

Whereupon, the Mayor declared the said motion duly carried and the said resolution adopted, as follows:

RESOLUTION NO. 1-2021

To provide for a notice of hearing on proposed plans, specifications, form of contract and estimate of cost for the FEMA Creek Bank Repairs Project, and the taking of bids therefore

WHEREAS, the City Council of the City of Griswold, Iowa (the "City"), has determined that it is necessary and desirable that a public improvement be constructed as described in the proposed plans and specifications and form of contract prepared by I&S Group, Inc. the Project Engineers for such public improvement, which may be hereafter referred to as the "FEMA Creek Bank Repairs Project" (and is sometimes hereinafter referred to as the "Project"), which proposed plans, specifications and form of contract and estimate of cost are on file with the City Clerk; and

WHEREAS, it is necessary to fix a time and place of public hearing on the proposed plans, specifications and form of contract and estimate of cost for the Project and to advertise for sealed bids for the Project;

NOW, THEREFORE, Be It Resolved by the City Council (the "Council") of the City of Griswold, Iowa, as follows:

Section 1. The detailed plans and specifications, notice of hearing letting, form of contract and estimate of cost referred to in the preamble hereof are hereby approved.

Section 2. The Project is hereby determined to be necessary and desirable for the City, and it is in the best interests of the City to proceed toward the construction of the Project.

Section 3. The amount of the bid security to accompany each bid is hereby fixed at 10% of the total amount of the bid.


Section 4. August 10, 2020, at 6:00 o'clock p.m., at the City Hall in Griswold, Iowa, is hereby fixed as the time and place of hearing on the proposed plans, specifications, form of contract and estimate of cost for the Project.

Section 5. The City Council hereby delegates to the City Clerk the duty of receiving bids for the construction of the Project before August 6, 2020, at 2:00 o'clock p.m., at the City Hall in Griswold, Iowa. At such time and place, the City Council hereby delegates to the City Clerk and/or the Project Engineers the duty of opening and announcing the results of the bids received. August 10, 2020, at 6:00 o'clock p.m., at the City Hall in Griswold, Iowa, is hereby fixed as the time and place that the Council will consider the bids received by the City Clerk in connection therewith.

Section 6. The City Clerk is hereby authorized and directed to give notice of the hearing and letting by publication of such notice in a newspaper of general circulation in the City, which publication shall be made not less than 13 and not more than 45 days prior to the date for receipt of bids and not less than 4 and not more than 20 days prior to the date of the said hearing. The notice shall be in the form substantially as attached to this resolution.

Section 7. All provisions set out in the attached form of notice are hereby recognized and prescribed by this Council and all resolutions or orders or parts thereof, to the extent the same may be in conflict herewith, are hereby repealed.
