

**RESOLUTION NO. 19-2019**

**Approve Fiscal Year 2019 Local Option Sales Tax Transfers**

WHEREAS, the City Council adopted the budget for the fiscal year ending June 30, 2019 on February 26, 2018 approving the transfer of Local Option Sales Tax revenues; and

WHEREAS, the revenues from Local Option Sales Tax are to be allocated as follows: 15% for Property Tax Relief, 30% for Community Betterment, 25% for Community Protection, 30% for Capital Improvements; and

WHEREAS, the City Council may transfer money between funds as allowed by the State Department of Management;

NOW THEREFORE BE IT RESOLVED, that the following transfers between funds are approved:
