

RESOLUTION NO. 28-2020

Adopt the Budget for the Fiscal Year Ending June 30, 2021

WHEREAS, the proposed budget for the fiscal year ending June 30, 2021, was published in the Griswold American on Wednesday, February 26, 2020; and

WHEREAS, the public hearing on the proposed budget for the fiscal year ending June 30, 2021, was held on March 9, 2020, at 6 P.M. at Griswold City Council Chambers; and

WHEREAS, the proposed budget for the fiscal year ending June 30, 2021, has an estimated total tax levy rate per \$1000 valuation on regular property of \$12.70915 and an estimated tax levy rate per \$1000 valuation on Agricultural land of \$3.00375; and

WHEREAS, the proposed budget for the fiscal year ending June 30, 2021, has total revenues of \$1,604,908 and total expenditures of \$1,524,757;
