The City of Griswold requires that individuals wishing to operate a Snowmobile, Off-Road Vehicle or Golf Cart, within City limits register with the City annually. The fee is \$35.00 per registration and shall expire on December 31<sup>st</sup> regardless of date of issue. A \$25.00 penalty will be charged to anyone who fails to renew their permit after January 31<sup>st</sup>.
